

## And people like CASA Volunteer "L"...

A 16-year-old girl was placed in independent living because her guardians were emotionally abusing her and taking advantage of her adoptive parents' death benefits.

Although it appeared that the child was mature and ready for independent living, she was unable to maintain her motivation for schoolwork, a disciplined daily routine, and healthy coping skills.

When her case was assigned to me, I spent time with her in person and on the phone, encouraging her to take advantage of services available and responsibility for her own progress. I even sent her a plant so that she would have something to care for.

It was the consistency and unconditional attention that nurtured trust and willingness on behalf of the child to share her vulnerabilities and hope for her life with me.

In my role as a Court Appointed Special Advocate, I successfully facilitated conversations and interactions between the service providers, school personnel, and the potential foster parents.




I was able to speak up on this child's behalf in court and the hearing officer agreed with many of my recommendations.

This young lady is living with a loving foster family, has graduated high school, obtained her learner's permit and has been accepted to attend a local community college. She now knows that her life is valuable and promising, and I am honored to know that as her Court Appointed Special Advocate, I was able to play such a significant role.

## Looking for a Volunteer Opportunity? Become a Court Appointed Special Advocate ..

CASAs are community volunteers who are trained to fulfill an important role. CASA volunteers work as fact-finders by developing a relationship with the child, their family and others who are a part of their lives.

Volunteers work as the extra set of "eyes and ears" to provide the court with as much information as possible prior to the judge rendering the best decision regarding the child's future.

## Our Mission

The mission of CASA for Kids, Inc. is to advocate for the best interests of abused and neglected children in the Washington County juvenile court system. By training community volunteers to serve as fact-finders and speak for the children in court, children's needs are met to ensure safety and permanency in their lives.

## Our History

CASA for Kids, Washington, established in 2002 as a 501c3 nonprofit organization will celebrate 20 years of advocacy in 2022. Following the death of a young abused and neglected child in 2002, a feasibility study was conducted by a group of concerned citizens, child welfare agencies, and juvenile court judge, the Honorable Katherine B. Emery to ensure that the voice of the child is heard in the courtroom. Judge Emery recognized a need for an "objective fact-finder for the court" who would focus on the needs and wishes of the child. That fact finder would make recommendations as to the best interests of the child, thus helping the court make more informed decisions.
